### City of Burlington Updates State Emergency

BURLINGTON, NC—

On April 30, 2020, Mayor Ian Baltutis signed an updated State of Emergency. This action rescinded previously issued States of Emergency. Beginning at 5:00pm on April 30, 2020, the City will enforce the Executive Orders of the North Carolina Governor and the following more stringent restrictions:

1. Car washes in the City of Burlington may remain open and operating for exterior car washes only. Other modifications to operations including no entry by employees into customer vehicles will be required for operations.
2. All public and private social gatherings of ten or more people are prohibited. A social gathering is defined as any event or convening that brings together more than ten persons in a single room or single space at the same time. Single spaces include both confined indoor and outdoor spaces.
3. Specific guidance regarding gatherings for funerals and burials
4. All events held on public grounds or hosted by the City of Burlington have been postponed.
5. All indoor recreation centers are closed, and all recreation programs are canceled.
6. All rentals of Burlington Recreation & Parks facilities/properties are canceled.
7. Outdoor public parks remain open (including Golf Course and Marinas).
8. No organized play is to be permitted at City sports fields or courts.
9. Public and private communal playgrounds are closed.

This State of Emergency remains in effect until May 8, 2020. Following May 8th, the State of Emergency will coincide with the Governor's Executive Orders, as amended, unless the State of Emergency is sooner revised, amended, or terminated by the Mayor.
